Dear Brother Ernie,

Warmest Fraternal Greetings!

Last Sunday afternoon, I was invited by Brothers from Bambang to attend a special meeting where one of the agenda is the up-coming RAD election and meeting to be held at Bolinao, Pangasinan on April 09, 2005. Another agenda regards to the letter of Brother Purisimo L. Tiam to your committee.

I've stayed up to 5:30 PM and went home and in the evening, I was visited by Brother Raymond dela Cruz. We had a very cordial conversation and I gave him a copy of Puring's letter and went home with a friend whom I was not able to remember his name.

That on the afternoon of Monday, April 04, 2005 I have received a message from Brother Edmar Par telling me that I am a traitor, etc. with different unsavory remarks and insulting accusations.

That let me refresh the events:

1. I was not informed by him that he will use me as one of the witness to the case of Brother Puring;
2. Nor I was informed or asked my permission by Brother Edmar Par to include my name in the circulated E-mail or Internet;
3. Neither there was any agreement between us that I would testify against Brother Puring;
4. That I can recall he called me up to informed me about his action against Brother Puring Tiam on the 1<sup>st</sup> week of March;
5. That he asked me to go out and spread to Nueva Vizcaya APO members that Brother Puring was not an APO member;
6. That I informed him that I can not do it without any black and white letter from the National Council for I might be sued for libel;
7. That he asked me where to send the copy of his complaint;

8. That I gave the number of Brother Joseph Ramirez to Brother Edmar Par;
9. That after few days, I was given a copy of his complaint (Edmar Par) thru Brother Joseph Ramirez and Raymond dela Cruz;
10. That sometime on March 23, 2005, I came to Manila to do my religious ritual in Cavite;
11. That last March 30, I did received a call from Brother Puring asking me what is the meaning of the message on the Internet that I was being harassed by them (PLT et al.);
12. That because of such news, I did came over to your office to clear Brother Puring and company and did made my own affidavit;
13. That as far as I am concerned, I find no crime committed by me by executing an affidavit and I wonder why Brother Edmar Par using insulting words and unsavory remarks when it was him who made all the mess and now pointing his fingers on me;

So Hence, may I request for a face to face confrontation to resolve the following issues:

1. If the case he filled against Brother Purisimo L.Tiam has a prima facie and had a probable cause, why he is acting unprofessional by using dirty words and threatening words who did not agree with him;
2. What is his basis of calling me and Brother Jojit Delizo traitors and been paid by Brother Puring Tiam to go with him or work in favor of him?
3. He claim (Bro. Edmar Par) that he was a member of the said CoMe if so, what justice and fairness could I expect to this kind of attitude and mentality?
4. That no investigation been made by him because of the following reasons:
  - a) No interviews been made to any APO members in the Region 02;
  - b) No officers of RAD have been interviewed or asked by him;
  - c) That how come that it was only Raymond dela Cruz made a report to him thru Internet when in fact he used to come to Manila if he want to submit his affidavit;

- d) Then how come they were not able to present documents related to their claims against Brother Purisimo Tiam?
- e) Why he was so mad at me when in fact he never asked my opinion or my side regarding that case;
- f) It was only then when he filed the case that I was informed.

Whereas thru verified information, I've presented to your office to clear myself from being dragged into the case of Brother Puring and ask your honorable Committee to investigate the action of Brother Edmar Par.
