I, Maricor de Leon, of Lambda Zeta Chapter, ID # 28384, batch 95' and a member of APO Pasigueno, would like to file a formal complaint against Bro. Mozart Saluta, Gamma Lambda, ID # 23234 batch 93'

On March 10, 2006 I went to my home town in Mindoro to attend the funeral of Bro and childhood friend Amor Mio Baticos, Batch 91' Lambda Chapter. He was a policeman in Puerto galler and died in a land ^{mine} explosion.

The funeral which commenced at 8:00am was held on march 11, 2006, at noontime we had lunch at the home of our late Bro. Amor Mio Baticos. Shortly thereafter we had a few drinks at Sis Volet Dimapilis Residence and then went to my house afterwards at about 9:30 in the evening I went inside my room to get some sleep. Bro. Jojo Baticos, clyde Salas, Genesis de Puno, Sis Riemalyn Famera and Christina Rivera. Were left outside the house. Fifteen minutes later (about 9:45pm) they went inside my room to say that they were leaving. Bro Mozart saluta was the last one to get inside my room. I got up to send them off when I realize that my cell phone was missing. While we were all looking for it, Bro. Mozart was no longer in vicinity. Subsequently, I was to learn from bro Genesis that he had at that time, gone with Bro. Mozart to Mozart house to get his scooter. Bro. Genesis said that while he stood waiting in the street for Mozart to get his scooter, he had seen Mozart hide something in his scooter but was not sure if it was a cell phone.

The morning after that incident, I spoke to Mozart at his home and asked if he had my cell phone. He said that it was not with him but promised me that within a week he would be able to give me back my cell phone.

On March 25 I received a text message that my cell phone was already available. As it turn out my cell phone had been pawned to a certain Nognog Galindez for 2,000 by Bro. Mozart, I called up Sis Volet to help me Redeem my cell phone from Mr. Galindez..

I am deeply grateful to Bro. Larry and Umbing who were kind enough to put up the 2,000 (Php) to redeem my phone. On March 26, 2006 I finally got back my cell phone from Bro. Elmer whom I requested to meet me in Boracay. Unfortunately the sim card is missing from the unit.


In this case I would ask no less than the expulsion of Bro.Mozart from organization (APO).
